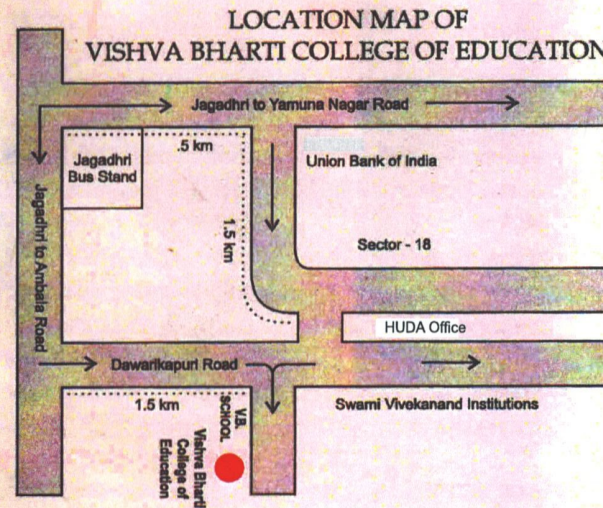

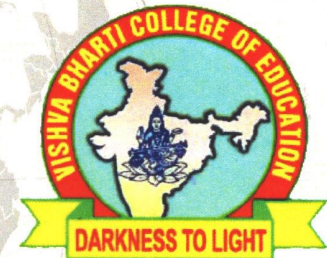

# ABOUT THE SEMINAR

No Detention Policy is a provision in the RTE Act 2009 (Chapter IV clause 16). The RTE Act has garnered much international accolade and is positioned as indicative of Govt. of India's (hereafter GOI) sustained commitment to various international treaties and conventions (Juneja, 2003). RTE's reception in India is ambivalent. With its provision prohibiting detention (failing) of students up to class VIII; also called the No Detention Policy (NDP), it has become 'arguably the most controversial' clause in the ACT (CPRI, 2015 b). The debate is fuelled by conflicting evidence from the field. Even GOI is gearing up to mandate the roll-back of the NDP (Hindustan Times 2016 a).

So it was thought worthwhile to obtain the views of various educationists, thinkers and scholars on the Pros and Cons of the “NO DETENTION POLICY: RTE ACT-2009” in the present Seminar.
